

# Allamakee County, IA Digital Data License Agreement

## License Terms

Allamakee County (hereafter referred to as County) has produced or co-produced digital geographic and non-geographical data sets including, but not limited to Assessment Information, Base Maps, Cadastral Layers, Zoning, Orthophotos, and Road Centerlines (hereafter referred to as Licensed Data sets). All Licensed Data Sets are copyrighted original works. They are licensed for use, not sold, and may not be resold or distributed in any manner except as specified or set forth herein. The County and its co-producers reserve all rights of authorship granted under United States and International copyright laws and agreements. By signing below, Licensee agrees to abide by all terms and conditions of this agreement. This document constitutes the entire agreement between the parties and supersedes any prior agreement. Any order for Licensed Data Sets must be accompanied by an original, signed license agreement.

## Protection of Proprietary Rights

Reproduction or redistribution of Licensed Data Sets or products derived therefrom outside of Licensee's organization or entity, without the express written consent of the County, is forbidden except as expressly provided as follows:

1. Redistribution of Licensed Data Sets to a consultant working for the Licensee is permitted only for purposes related to Licensee's Business. Such consultants may not further reproduce or redistribute said Licensed Data Sets and such copies must be returned to Licensee upon completion of the consultant's work. Licensee must inform any third party Licensed Data Set user of all stipulations contained herein.
2. Reproduction or redistribution of hard copies may be derived from Licensed Data sets provided they are used for non-commercial purposes only (e.g. government agency publication or use by a non-profit organization).

Any sale distribution is prohibited without prior approval from Allamakee County.

The reproduction of any hard copy products, as provided by the County, with the intent to sell for a profit is prohibited without the written consent of Allamakee County.

## Indemnification, Disclaimer of Warranty, and Liability

The burden for determining "fitness of use" rests entirely upon the requester/Licensee. The County and its co-producers will not be liable in any way for accuracy of the data, and assume no responsibility for direct, indirect, consequential, or other damages.

Licensee agrees to indemnify, hold harmless and defend the County, its employees, officers, officials, agents, representatives, and co-producers from any and all claims, damages, liabilities, and expenses arising from, in connection with, caused by, or resulting from Licensee's use of Licensed Data Sets or products derived therefrom.

ALLAMAKEE COUNTY SPECIFICALLY DISCLAIMS ALL WARRANTIES; EXPRESSED OR IMPLIED, INCLUDING BUT NOT LIMITED TO, IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. IN NO EVENT, SHALL ALLAMAKEE COUNTY AND ITS OFFICERS, OFFICIALS, EMPLOYEES, CO-PRODUCERS, AND AGENTS BE LIABLE FOR ANY LOSS OF PROFIT OR ANY OTHER COMMERCIAL DAMAGE, INCLUDING BUT NOT LIMITED TO SPECIAL, INCIDENTAL, CONSEQUENTIAL, OR OTHER DAMAGES.

## Scheduling

Orders for Licensed Data Sets do not command priority over other projects or work demands of the County. Requesters are advised that significant delays may sometimes occur due to staff

shortages or schedule constraints. Orders will be filled within normal municipal operations. Requesters are encouraged to order early.

**Costs**

Allamakee County, according to the attached price schedule, licensed the use of Licensed Data Sets. Fees are not refundable. Purchase orders are accepted from government agencies. Prepayment is required for all other entities. Checks should be made payable to "Allamakee County GIS".

**Updates**

Licensed Data Sets are licensed and distributed in an "as is" condition, on a one-time basis. The County is under no obligation to inform Licensees of data updates, alterations, or accuracy errors discovered thereafter. The burden of ordering and paying for updated copies of data sets rests entirely upon Licensee. Any and all revisions will be made at the County's discretion.

**Credits**

Any paper copies derived in whole or in part from said Licensed Data Sets, shall clearly indicate their source and copyright as Allamakee County. If Licensee modifies the data in any way whatsoever, Licensee is obligated to describe the modifications performed on the paper copy. Licensee specifically agrees not to misrepresent said Licensed Data Sets, nor imply that changes made by Licensee were approved by the County, unless express written permission is obtained from Allamakee County.

**Authorization**
