Solar Utility Ordinance: The public hearing opened for discussion. Jack Sweeney talked about what he heard from the community and his thoughts about not utilizing high CSR ground for solar. He mentioned that more research needs to be done where commissioner Severson stated that Runkle and commissioners have been working exhaustively on this ordinance along with the research it required for a long while. Duane Leppert gave his thoughts about having a 15-acre cap per site instead of 30 acres. Runkle read aloud a letter she received from the Iowa Conservative Energy Forum regarding the ordinance. Beth Esser was present on Zoom and answered a couple questions that came up concerning how solar utility is connected to the grid. Dean Peterson mentioned he agreed with Duane and gave a lot of complimentary comments to the commission on their work with the ordinance. Jack Sweeney's final comments were that the ordinance needs to be less restrictive and allow more solar. Severson made a motion to send the solar utility ordinance to the Board of Supervisors for approval, seconded Egan. All in Favor. MCU
